

their skills by becoming trainees. Many of these new translators are assigned

with several documents from different linguistic fields and this task can

present difficulties for inexperienced translators. The aim of this research

project is to propose the creation of an online termbank for inters of the

Translation Department. This reference tool will help to overcome the most

common mistakes done by interns and improve the quality of the translations

they render. This research was performed under a mixed approach, as it

required deep analysis over facts and numerical information in order to reach

the aims proposed, which lead to conclude how important it is to implement

of a termbank and the possible benefits that it may bring in the future.

#### INTRODUCTION

#### **Title of the Project**

Development of a proposal for an online free access Termbank for Translation trainees at the Translation Office of the UCSG

#### Problem and justification

The title of this research project is Development of a proposal for an online free access for Translation trainees at the Translation Office of the UCSG. This project aimed at the improvement of the quality of Translations. The selection of this topic is the result of the analysis of a specific environment and the identification of a concrete problem.

The Catholic University of Santiago de Guayaquil is a private institution, which provides services of higher education in the city of Guayaquil, Ecuador. The Faculty of Arts and Humanities offers the program of English language with minors in bilingual teaching management and translation studies. Students from the English Language School are required to undertake internships to graduate. These internships are mandatory and serve as a way to put the knowledge of students into practice. Bilingual teaching management students must undertake internships in the educational area, while translation students must perform translation service related tasks (translation of documents, interpreting, etc.).

The Catholic University of Santiago de Guayaquil has a Translation Department, which gives students, from the minor in translation, an opportunity to become paid interns. The Translation Department receives

documents from clients that need to be translated, whether it is L1 TO L2 translation (from English to Spanish in this case) or prose translation (from Spanish to English in this case). Interns are given a certain amount of documents for them to work with, therefore they put in practice what they have learned in classes. After observing and analyzing how the process of these internships are carried out, a problem worth of study was identified

The problem identified is that the documents to be translated belong mostly to specific linguistic fields and many of the interns do not have a clear knowledge of how to translate these documents respecting the format and being faithful to the linguistic field. After the translation is handed by the intern for revision, the task of revising and most of the time redoing the translation is a very time-consuming duty for the head of the Translation Department. Keeping consistency is a problem too, as there is not a common terminological databank for students to be familiar with; thus, many of them use a different term that has to be corrected by the translation department before delivering the final product to the client.

The development of a shared terminology databank can help to overcome these problems by providing interns of the translation department the necessary tools to become more familiar with terms used in a specific linguistic field (legal, scientific, academic) and improving the quality of their translations overall regarding the consistency, the formatting, and word choice. Thus, making the task of revising translations, less time-consuming for the head of the translation department.

The lack of the study of this problem can lead to a consolidation of inefficient

professional practices for interns. For example, an incorrect formatting for documents that require a specific format to be handled (diplomas, manuals, transcripts), disregarding equivalence of terms and a low quality of translations in general. Additionally, this study contributes not only to the practice, but also to the study and analysis of essential concepts related to translation studies like terminology, data bank building, and linguistic fields.

#### **Research questions**

How applicable is the creation of a termbank for the standardization of terms of the renderings performed by the Interns of the Translation Department?

What are the most common mistakes made by Interns of the Translation Department?

What benefits and advantages could bring the creation of a termbank to the Translation Department Interns' rendering process?

How could the quality of the Translations performed by the Interns of the Translation Department improve with the implementation of an online termbank?

#### **General and specific objectives**

#### General objective

To develop a proposal for the creation of an online terminology databank aimed to the improvement of the quality of the translations performed by the Interns of Universidad Catolica Santiago de Guayaquil the Translation Department.

#### **Specific objectives**

To determine the most common translation mistakes made by the Interns of the Translation Department

To examine the viability of the project regarding the building of the termbank.

To examine the interest of students towards the proposal of the project and how they will make use of it to get the desirable results.

To analyze the benefits that the creation of the project could bring for the translation students and the translation department, regarding quality improvement.

#### Literature review

In order to fully develop the topic, a deep literature review had to be performed. The literature review included points of view and theories of authors and experts in areas such as terminology, linguistics, databank creation. These points of view, theories and perspectives helped to structure the selected topic and shaped the nature of this research project:

#### **Terminology**

In a broad way, Sager defines Terminology as the "study of the lexicon or the lexical items, this broad interpretation, however, is rejected by most terminologist as it does not fully comply the extant nature of terminology itself" (1990, p.3). Later in his work, he provides a more detailed explanation of Terminology proper to the contemporary usage of the word in the linguistic field by providing 3 definitions of the term:

- the set of practices and methods used for the collection, description, and presentation of terms;
- A theory, i.e. the set of premises, arguments, and conclusions required for explaining the relationships between concepts and terms which are fundamental for a coherent activity under;
- 3. a vocabulary of a special subject field

Terminology and translation emerged from the urge to express thoughts that are specialized or the need to solve problems associated with how concepts are understood. The two disciplines have in recent times received scientific

recognition and therefore there is need to reaffirm their status by highlighting the distinguishing factors that exist in comparison to other disciplines. Both contain a cognitive foundation, as well as a linguistic and communicative basis that are buried in a specific social framework; language, being the vessel, carries the concepts of the speaker to comprehension (Cabre, 2003, p. 87).

Terminology can be defined as the science that aims to study terms that are used in specialized subjects inform of lexical elements that are obtained in those fields or are a modification of the elements pre-existing in other disciplines (Cabre, 2003, p. 163). Though there is a slight difference in definition, the latter emphasizes on the various methods in which terms are formed expressing a likelihood that each term is highly influenced by the patterns that already exist in regard to the term formation for a given domain (Sager, 1994, p. 352). Both Cabre and Sager do however agree that there are three notions of Terminology, from the concept and term to how something is defined. Concepts are usually understood by relating them to other concepts, and not just in isolation, being that they are thoughts that enhance understanding of the world around humans (Cabre, 2003, p. 164). According to their models, data banks of terminology usually contain units of information that generally have defined concepts. Each term is a contribution of various terms in the distinct languages, bearing in mind that sometimes it is a challenge to stick to these given principles. More so, in items of terminology that are either monolingual or multilingual that have possibly gone through various levels of clarity and processing (Talavan, 2016).

Other terminologists expand on the more contemporary definition of the term

given by Sager, especially by establishing an interdisciplinary aspect to it. Cabré (1992) for example, explains that Terminology focuses in the study of terms/words belonging to either a specific subject field such as physics, chemistry, legal, etc or to a determined profession.

Concepts are usually understood by relating them to other concepts, and not just in isolation, being that they are thoughts that enhance understanding of the world around humans (Cabre, 2003, p.164). Though there is a slight difference in definition, the latter emphasizes on the various methods in which terms are formed expressing a likelihood that each term is highly influenced by the patterns that already exist in regard to the term formation for a given domain (Sager, 1994, p. 352). It is evident that the two disciplines have in recent times received scientific recognition and therefore there is need to reaffirm their status by highlighting the distinguishing factors that exist in comparison to other disciplines

These experts also express the importance of the relationship between terminologies with many other disciplines, as it has been established as an interdisciplinary activity (Sager, 1993, p.3).

Among the disciplines of importance for Terminology are: Translation (Cabre, 2010, p. 1) Terminology management, English for special purposes and Terminology Databanks, all of these disciplines have existed for many years and they convey and converge in the practices of terminological work in general. The latest aspect (Databanks) being the most important element to review for the nature of this study. (Bernth, McCord, and Warburton, 2003)

#### **Terminology Management**

Terminology management is the process by which terms are documented in a manner that is orderly and systematic (Talavan, 2016). It could also be referred as the organization of terms with the basis of a clear set of rules for accuracy purposes as well as the effectiveness during translation. Both definitions clearly indicate that there is a set of standard rules that govern how terms are managed for them to have the exact meaning intended during translation (Sager, 1993).

Sager (1993), later on, states that Terminology management is crucial for the creation of a terminology databank, as it is the basis for the process of creation of a compilation of terms that will serve as a reference source in order to achieve the desired standardization.

Terminology databanks are not a new concept, they have existed since technology allowed to collect, store and manage information (Sager. 1990). Databanks were traditionally created to meet the specific need to aid in the translation process.

There is a variety of databanks:

For example, "TermScience", is an online access platform developed by INSTI (Institut de l'Information Scientifique et Technique), whose main objective is to serve as a terminology consultation resource (specialist vocabularies, dictionaries, and thesaurus) for the European Parliament. Other examples include Tilde terminology which involves extraction of terminology and cloud lookup. It addresses the language workers' necessity through Providence of services of online terminology that facilitate key

terminology duties. InterActive Terminology for Europe is a database for the European Union's terminology which involves approximately nine million terms in the twenty-three official European languages. EuroVoc is multidisciplinary, multilingual thesaurus which accommodates particularly European Parliament activities (European Parliament, 2017). The United Nation's terminology database consists of both specialized and technical terminology in official languages such as Arabic, English, French, Russian, Mandarin, and Spanish. It also covers frequent phrases utilized by the UN organization.

#### Specialized Language or English for Special Purposes

English for Special Purposes refers to research done in language as well as the instruction that concentrates on the needs and practices that are specific to communication for certain groups (Hyland, 2007, p. 391). Specialized language is a dimension of specialized knowledge that sometimes contains an aspect of the common language. The two definitions give a broad array of scope but the uniting factor for both being that the language is for a certain group just like most languages.

English for special purpose or specialized language examples include; text structure which involves presentation of information in an order that is logical where the meaning is gradually exhibited. Connectives also link ideas hence claims on knowledge may be justified and formed. Technical language involves use of technical words, which are specific to a certain field (NAGY, 2014). Condensed language is another example which involves information being densely compressed.

#### **Translation**

Translation can be basically defined as "the transfer of a source text to a target text, conveying the meaning intended in the target text as much as possible." The level of preciseness greatly varies depending on the person translating it (Cabre. 2003, P.88). Translation can also be referred to "carrying the meaning of a text from one language to another." In both cases the main point being that it is a transformation (Antia, 2000). This common definition can be considered as the standardized nature of Translation Itself.

#### Relationship between translation and terminology

Terminology is a study of terms and their application while translation is a communication of the source-language text meaning through an equal text-language text. Translation and terminology are intertwined in that translation technically accommodates translation of various types of texts thus it requires relevant terminology and subject level' high knowledge. Moreover, terminology has a significance in translation such as in patents and highly formulaic as well as technical writing that tends to have a repetitive nature. Through the use of terminology databases along with translation memories, computer-aided translation becomes especially appropriate. Additionally, when a translation of a particular term is urgent in solving a specific translation obstacle then terminology is prevalent. (Cabre. 2003, P.103)

#### Relation between translation and technology

Virtually speaking today, a huge percentage of translation is aided by technology. These technologies have enabled translators to shift their focus from repetitive tasks to task that require human creativity. Information

technology has seen massive change over the decades. This shift owes to the flexibility, swiftness, ease in use as well as more affordable. Global markets today are at an international scale which leaves little option for disciplines to follow suit and translation is not an exception. There has been great need for translation cooperation due to the many spheres that are occurring daily, with the notion that people, by all means, have the right to communicate using a language they understand, without it being a limiting factor (Fulford and Granell-Zafra, 2005).

#### Technology applied to translation

Translation studies have been seen to have direct relevance to applications of processing language (Foo and Merkel, 2010). Technology today is used in translation to describe and acquire the instrumental competencies of the translators, utilization in distance and eLearning as well as studying of disciplines that are closely related to the new technologies (Gil and Pym, 2006). Pragmatic, real-world and contextual information exhibited difficulty in programming thus attention has changed to seeking ways that technological tools can aid professional translators.

In our current society that is globalized and needy for information, technology applied to translation has become vital to meet the demands of escalating markets for rapid delivery of quality texts in numerous languages. Application of technology in translation has also become a significant tool of achieving quality levels needed in communication in the society. (Talavan, 2016).

#### **Computer Assisted Translation**

When a software is used to help individuals to translate certain information it

is known as Computer Assisted Translation (CAT). This is a preferred method by many mainly because of the time taken to complete the tasks (Fulford and Granell-Zafra, 2005). It can also be referred to as a type of translation that utilizes software program which supports and facilitates the process of translation.

#### Information Technology

Information Technology is a very wide term which encompasses a huge scope in the field of technology. It can be defined as a sector that deals with computing more specifically in transmitting of information or data or even the systems involved in facilitation of communication. These may broadly also range from hardware, software as well as telecommunication (Foo and Merkel, 2010). It could be defined as the utilization of any computer networking, storage among other physical devices to produce, keep, secure and transfer different forms of electronic data.

#### **HTML** programming software

HTML is a programming language that is utilized in the making of a web pages and applications. There are various software (Foo and Merkel, 2010). It is a combination of codes or markup symbols put in a file with the intention of appearing on the World Wide Web page browser. The display seen of most contentment on the internet pledges its allegiance to HTML (Gil and Pym, 2006).

#### **Databank creation**

A data bank is generally an information repository on a single subject or

more, which is organized in a manner that accommodates remote or local retrieval of information. Data banks are utilized to withhold unlimited input data amounts which have the capability of being fed automatically into any Web application. Data bank creation involves creation of a physical file in the system of host file and formatting is done for utilization as a desired databank (Broussard and Spring, 2005).

#### **Database management**

Refers to actions or tasks that protects data by keeping applications that are data driven at top notch. Such tasks include but are not limited to data recovery and backup, partitioning of data, storage, masking, and replication (Foo and Merkel, 2010). Database management could also be simply refer to how information that is stored in a computer system is maintained (Gil and Pym, 2006).

#### Methodology

It is important for a researcher to have stablished the philosophical framework of their study, the approach and the method before starting the research process. The philosophical framework aim is to help organize the ideas and concepts; it is about the how and the why. The approach is about how the research will be conducted and the tools. Finally, the method is about how the research is presented to the reader.

The philosophical framework that will be used in this research projects is pragmatism which relies and focuses on identifying what works, this knowledge will arise from examining and determining problems in a particular situation and what works in order to overcome them. In the context of the present study, the problem identified is the lack of a quality assurance process by the interns of the Translation Department, this problem could be overcome by the application of a termbank which will help in standardization of terms as well as the quality improvement of said translations. In summary, pragmatism is the most appropriate approach because it aims to find a practical solution for a real problem, which is the key goal of the study

This study adopts a mixed approach; as it will use both qualitative and quantitative methods as a creative combination in order to fully answer the research question. A great amount of the information was compiled in numerical data, such as surveys, documentation analysis and establishing term use frequency and non-numerical data like interviews, term collection. It is necessary to take both of these data into consideration in order to establish better results for the purpose of this study. However, it is necessary to point out the necessity and the importance of the qualitative approach due to the

nature of the study. Hutter and Baily (2010, P.9) states that: "Perhaps one of the main distinctive features of qualitative research is that the approach allows identifying issues from the perspective of your study participants, and understanding the meanings and interpretations that they give to behavior, events or objects."

In this research work, the method selected is case study. According to Simons (2009, p.3), the definition of case study is: "The study of the singular, the particular, and the unique." Within the limits of this project, we can propose that case study is the appropriate method because there is a particular situation with its own characteristics that deserves to be studied with the degree of attention to detail that this method represents. The existing situation will be studied through observation and other instruments like interviews, surveys, which are common for this type of research.

#### Instruments

Due to the nature of the research project, several instruments were used in order to gather quality information needed to achieve its goal. The instruments that will be applied are an interview with the head of the translation department, Sara Rivadeneira; Surveys to Interns of the Translation Department; and documentation analysis of the translation handed to interns. Through the use of this variety of instruments, a confirmation of the existence of this problem is expected so as to explore the benefits of the application of a termbank to the translation process.

#### Interview to the Head of the Translation Department

The instrument designed to gather information from the Head of the

Translation Department was an Email Interview which 5 questions. Their contribution to this study will be analyzed in the following lines:

- -Question number one aims to determine an existing problem in the translations rendered by the Interns and explore what might be the reasons for this situation-
- -Question number two seeks to examine if there has been any attempt to solve the problems that emerge among the interns of the Translation Department by doing their renderings.
- -Question number three tries to establish a clear reference of the commonly translated documents by the Translation Department thus being able to identify the subject field in which interns have difficulties in the translation process
- -Question Number four facilitates the analysis of the importance of building a termbank in order to solve translation problems in a given context. In this case, the context is given by the work of the interns of the translation department.
- -Question Number five provides a wider perspective about the potential benefits of building a termbank as well as possible downsides.

#### Survey applied to the Interns of the Translation Department

In order to get information directly from the Interns and have their point of view of the problem, a five-question survey was designed and applied. These questions seek to prove the existence of the problem and to confirm the need of a consultation resource that interns could use in their renderings.

The contribution of each one of the questions within the survey will be analyzed in the following lines:

- 1- Question number one seeks to find and determine the different aspects that might hinder the task of the Interns of the translation department during the translation process.
- 2. Question number two is aimed to find the most challenging subject field for Interns to translate.
- 3. Question number three facilitates the existence of a continuous problem regarding the lack of any official consultation resource for interns during the translation process
- 4. Question number four directly seeks to determine if the creation of a termbank is necessary from the perspective of the interns and entails an explanation and reasons why they think it might be necessary and how it could be used during the translation process as well as its benefits.
- 5. Question number five attempts to establish an order over the relevance of the different benefits that the creation of the term bank might bring to the process.

## Collection of documentation handed by the Translation Department

In order to determine the most common types of documents handed to interns of the Translation department and the characteristics of said documents, an analysis had to be carried out. The purpose of this analysis is to study the relationship between the specialized terminology and the

mistakes made by the interns when rendering these specialized documents.

Also, identify problematic cases, frequency of uses and mistakes of such terms (Cabré Castellví, 2003).

The analysis was carried out following these steps:

- 1. Request the Translation department a variety of texts commonly handed in and translated.
- 2. Read and identify the linguistic field of each document and separate them.
- 3. Analyze common terminology, formatting, and improvements between the translations handed by the interns and the final corrections

#### **ANALYSIS OF THE RESULTS**

## Analysis of the Documentation Translated by the Translation Department

During the process of gathering documentation for analysis in the context of the present research project, it was possible to obtain academic, legal and technical texts from the Translation Department of the Universidad Catolica Santiago de Guayaquil.

An analysis of this documentation is provided through the following lines:

#### **Document no.1 – University Degree**

This document can be classified as an Academic document as it is a Bachelor's degree. It's most important aspect to follow for interns translating this type of documents is its formats and the specialized terms in it. These terms cannot be changed to will of the translator without consulting to documents originally elaborated in the Target Language. Regarding the format, it is important to mention the presence of elements such as seals, signatures and the position of the text itself. For this type of translations, interns are required to perform a WYSIWYG (What You See Is What You Get) type of translation, which focuses mainly on maintaining the translated document's visual presentation as close as the original document as possible.

Signatures and stamps have to be rendered using an inter-semiotic translation (visual elements into written text), in order to convey visual elements into written text. For example when rendering illegible signatures and/or official stamps.

The following image shows the original representation of visual elements such as stamps, signatures and other similar elements commonly found in this type of academic document.

The following image represents the most common way to represent visual elements from the source text to the target text. Signatures, stamps, and other similar semiotic elements cannot be just simply copied and pasted and require to be rendered in the way shown below:

Unnecessary changes are completely discouraged and free of translation performance is totally limited as an almost literal translation of the text

required, with some exceptions in which an exact match has to be found. For example, for the term "Doctor" there are two possible options: "Doctor in medicine" and "Physician" however, translators have to look up documents originally issued in English in order to identify which one is more suitable for these types of academic documentation.

#### Document no.2 - Affidavit

This document is known as an affidavit, a legal document used in order to certify the veracity of a person's statement in front of a notary public. Thus, the document belongs to the legal Linguistic field. For this type of translation, it is necessary to know the usage that the document will be given. If the document is required to give certain degree of relevance in the target language for legal purposes in a court, for example, many annotations have to be done and many terms have to be given an explanation because the legal system of the source text and the legal system of the target text can be different. On the other hand, if the purpose of the translation is only to make the document readable for the target audience, like in this case, it suffices to find equivalence among specialized terminology. A few examples of this are: "declaración juramentada" to be rendered as "affidavit" by rendering this term with "sworn declaration" the connotation of the word will not be complete because the term in Spanish implies that it has to be sealed by a legal authority known as "notary public". This latter prefab term "notary public" is another example that shows that the supposed "correctness" is not always the same as accuracy. The original Spanish term is "notario publico" rendering this term as public notary, is a wrong translation even though it is grammatically and syntactically "correct", the most appropriate term is the one mentioned previously. Many of these common mistakes of terminology choices could be avoided by having a common source of consultation based on the type of document to be translated.

#### **Document No. 3 – Plastic Factory Test Report**

The third document to be analyzed for this project is a plastic factory test report, this document can be classified in a technical field for the high level of the terminology its used and how this level of word choices have an important role. In documents of this field, accuracy is crucial; in this case, the name of each one of the items of the report has to be as close as the original word in terms of semantic meaning. Other relevant element of this rendering is the constant use of ISO certifications and code of certain plastic pieces, which cannot be translated, and have to be completely carried over from the Source Text to the Target Text.

The following image illustrates the previously mentioned statement:




Image 3 Original factory Test report – English

This type of translation has to be simple, clear as the original text, the free will of the translator is limited to the freedom of the source text itself. Other good examples of similar texts include manuals, instructions of use of certain machinery, which have to be translated keeping in mind that the message conveyed cannot be altered by any means.

#### Analysis of the Interview With the head of the translation department

With the interview with Miss. Sara Rivadeneira, the following results were

#### obtained.

The Translation Department has stated that interns undertaking their internships have many mistakes through their rendering process, among these mistakes the following were highlighted by the interviewee: check for grammar, recurring information for academic documents like seals and disregarding completely the format of the documentation handed in. Unnecessary Stylistic changes are done by students when translating documents with a special register, such as degrees, certification letters, etc. Word choice is also a common mistake as there is no consistency among the different versions student's renderings of common terms such as "aprobar materias", some interns translated this terms without checking documentation originally issued in the Target Language. Many of these mistakes have been tackled by implementing a primary "documentation" training for interns starting their internships. Students perform this process by analyzing previously translated documentation. However, many of these previously stated mistakes keep happening with students that have gone through this "training process".


Among the most common types of documents received by the Translation Department, it was stated in the interview that these include: academic documents with frozen register mainly, like transcripts, university certificates, degrees, etc. After consulting the head of the Translation Department about her opinion regarding the creation of a Terminology Databank she stated in a clear way that this tool could help to the improvement of the quality of the translations of interns, and it would serve as a guiding and support tool through their Internships. She also stated that there does not seem to be any

disadvantage towards this proposal, but rather a good future for a project of this type. Stating that "It would be a good source of terminological enrichment for translation practicum." and highlighting the importance of a web based structure for future updates and contributions.

# Analysis of the Survey Performed to the Interns of the Translation Department of UCSG.

After performing the respective survey aimed to 10 Interns of the Translation department, the following results were obtained:

For the first questions, Interns were asked to select the most difficult aspect that they had faced while rendering a document.




Graph 1 Survey to Trainees - Question No.1

30% of the Interns agreed on the fact that the most difficult aspect when rendering was the subject field of the documentation and its terminology. On the other hand, other 50% Indicated that the lack of a guide through the translation process was the difficulty they had to face and only the remaining 20% referred as the formatting of documents as a difficulty in their

internships. These results revealed the level of importance that has to be given to these problematic aspects in the translation process. In this case, we prove that the creation of a tool similar to the one proposed in this project, the missing guidance could be filled with the features it presents, as it will serve as a consultation resource for trainees.

For the second question, interns were asked to select the subject field which has represented an issue with their translations. Four options were given: legal documentation, academic documentation, scientific documentation and technical documentation. This list of options was selected with the analysis of the documentation handed by the translation office and the Interview with Sara Rivadeneira, who stated and listed the most common translated documents in the Translation Department. The following chart will represent the results pbtained:




Graph 2Survey to Trainees - Question No.2

40% of the interns selected academic documentation as the most problematic field to translate; other 40% similarly selected legal documentation. 10% Of the Interns selected technical documentation and the final 10% scientific documentation. Proving that the main focus of the

termbank has to be legal terminology, academic terminology as well as previously translated and original documentation belonging to these linguistic fields.

Question number three intended to show if there has been any consultation resource available for interns as an aid during the translation process with information about terminology or the formatting of the documents commonly translated.

90% of the students answered that they counted of a consultation resource during their translation process and 10% did not. These results reveal a different outcome than the expected. However, even with the existence of this resource, quality of translations does not improve significantly as stated by Sara Rivadeneira.

In question number four interns were asked about their opinion over the implementation of a terminology databank and secondly to write in a brief way the possible benefits it could bring in order to solve the existing problem. The results were very similar in content, for example, one of the students stated "Because it can make the translation process less prone to mistakes

and also improve the time in which translations can be done". Other student similarly stated "Because it would save time and increase uniformity/standardization of the TT and reduce ambiguity". These answers are a small extract of all the answers, which followed a similar line, regarding the possible benefits of this tool.

Question number aimed to give an order according to the importance of the benefits that could bring the implementation of a termbank. After analyzing the answers provided by the students.

The most important benefit proposed was that the implementation of a tool of this nature could help them to improve significantly the time in which translations are done. On the second degree of importance, student interviewed focused on the improvement of the time in which translations are handed, this time, which is mostly consumed proofreading could be improved with the usage of a termbank. Interns' survey results showed that the consultation of specialized terms is a step commonly done in order to translate specialized documentation and it will be very helpful to implement this feature in the termbank.

#### CONCLUSIONS AND RECOMMENDATIONS

After the analysis of the results obtained with the implementations of the research instruments, the following conclusions were made:

According to the Interview with the Head of the Translation Department and proofreader of the documents handed to clients, Interns of the Translation Department tend to make mistakes when performing specialized terminology translation, as in the case of academic and legal documents.

These mistakes include the incorrect formatting of the documents, an incorrect word choice for specialized terms that disregard their linguistic field. Also, the analysis of the documentation showed that students tend, in the case of academic documents to mistranslate prefabricated terms such as "physician" for the way to refer to a Doctor in medicine in degrees, "Pass" referring as approving a subject and "Transcripts" for the academic record of subjects. Often using their own version of said term, proving that terminology consistency is a recurrent problem.

The survey given to students showed that they have difficulties rendering documents especially of academic field such as degrees and transcripts and in a similar level legal documentation, The former supports the need to implement a quality assurance and assistance tool for students rendering documents under the aforementioned circumstances.

The implementation of a termbank could bring benefits such as improvement of the quality of the translations rendered by the Interns of the Translation Department overall, thus, improvement of the format of certain type of documents that require strong format resemblance between ST and TT

(degrees, transcripts, academic records); the word choice and presentation of the work itself to be handed to the proofreader for revision. And an improvement over time of the translation process in general.

Students who have performed Internships in the Translation Department had the chance to express their opinion and their position over the implementation of a termbank aimed for the standardization of terms and improvement of the translation process with the survey applied. Interns showed total interest over this tool and listed different reasons of how it could be helpful for them. Also, Sara Rivadeneira stated, in the interview, the upsides of the termbank being web-based gives the possibility to improve it and expand it in the future according to the needs of the Translation Department and their translation requirements conditions.

Based on the above-stated conclusions, the following recommendations are made:

It is recommended that the Translation Department encourages and implements focused training on specialized documentation of Academic field since it represents the majority of the work it is handed to the interns.

Special focus is recommended on the formatting of documents that contain specialized formats; these formats could be uploaded in the termbank in order for the information to be available for all interns that require using them for their renderings.

It is recommended the implementation of a termbank. This tool will serve as a consultation resource for Interns of the Translation Department in order to improve the quality of the translations, the consistency, and standardization

of specialized terminology. This termbamk must be a web-based tool which will help it to be constantly updated with new entries and new formats of documents as required.

#### DESCRIPTION OF THE PROPOSED PRODUCT

The product proposed for this study consists of a free access online term bank with terms previously analyzed, collected and organized. The termbank focused and is divided into two different linguistic fields academic and legal, which were chosen based on the gathered information that has proven and shown which are the most common documents handed and translated by the Translation Department.

Through the following lines, a conceptualized idea and an explanation of the proposed termbank will be shown, along with illustrations of the respective features to be implemented.

The termbank's home page shows the three main features presented of this tool:

- Search for a specific term,
- Search for document

The following illustration represents a visual conceptualization of the proposed termbank homepage.

The proposed termbank will provide the definition of the term in two contexts: general usage and specialized usage regarding the linguistic field. The user can search terms by typing the respective the desire terms in the search bar, and clicking on the "search term2 button. The user will be able to get the information available of such term. Whether it is a term originally in English or in Spanish.

The following illustration represents a visual conceptualization of the proposed termbank applying the search function

Once the term is entered into the search bar, a new window will pop up presenting the Original term in Spanish or English. The information will be presented in the following format

The propose platform will also provide the user with access to different formats of previously translated and un-translated documents. These documents are normally received by the translation department and will be used for the user for consultation purposes. These documents will be collected and provided by the Translation Department. As it was found during the analysis of the results, the two fields that need main focus for interns and the Translation Department are academic and legal documentation.

The user can look for the documentation by selecting the specialized linguistic field from the available options

The following illustration represents a visual conceptualization of the two linguistic fields available to choose for the user

Once the user selects the desired linguistic field. A list of documents

corresponding to the field will be show. These documents can be downloaded in .docx and .pdf formats. By this, Interns can see documents revised in order to look for correct formatting and correctness in the word choice for certain specialized terms.

The implementation of such idea can be a great aid to the translation process of interns and will serve as a way to decrease the frequency of mistakes made by the interns. During the development of this project and the analysis of the information interns showed great interest towards the termbank and its features from the Translation Department and from the Interns.

Using an online termbank over a printed booklet is more convenient and cost

effective considering the fact that it can be constantly updated in less time and it is accessible to any person from any computer with internet connection working from home, this term bank can also be updated with new terminology as needed for future works. Thus, leaving a constantly updatable source of information that could be used to train interns for years to come.







Como sabe, mi tema trata mucho sobre los procesos del departamento de traducción y sobre los errores comunes de los interns.

a continuación detallo las preguntas:

1. Which are the most common mistakes when translating that you, as the proofreader, have identified to be done by the interns?

Well, we need to set a framework for that.... there are several kinds of mistakes at the different levels of translation check and proofreading.

At the level of checks:

#### Basic check

Students tend to omit or partially omit information. Especially when that information is written in seals and stamps or when it is in the header or footer. They also disregard de format or the fact that there are mandatory inscriptions at the bottom of each page.

Spelling and grammar check

Some students tend to mispell words, especially when these words are cognates. On the other hand, when in Spanish the senteces are structured with some form of the word "se", the students produce all sorts of faulty renderings.

#### Stylistic check

At this level, most students tend to remain ST biased and this is a BIG problem when it comes to translating letters or documents that contain frozen register.

Choice of words is an issue here. Students disregard the linguistic field they are managing. For example, when it is something academic, like a transcript, they use the word "approve" instead of pass; the word "assist" instead of attend; the word "rector" for school transcripts instead of "principal" ... well! ... at this level the list is way long and discouraging.

1. What strategies have been implemented by the Translation Department in order to overcome these common mistakes?

There are some strategies at this point: Basic level interns have to carry out a documentation process based on other student's translations so they can analyze their mates' mistakes as a way to train for their own performance. Interns that are already rendering documents are sent the final version of their TTs and are required to check their performance and improve it. They are also required to write memoirs of the process so they can reflect upon their own practicum.

Another thing that I could mention is the fact that some students are provided sample documents whenever available, however, this strategy has proven detrimental... since students tend to omit the changes to fit the actual ST.

1. Which are the type of documents that are commonly translated by the Translation Department?

Well, there are all sorts of documents, but a great percentage consists of academic documentation like transcripts, degree certificates, endorsement letters, syllabi, etc.

1. Do you consider pertinent the creation of a termbank to solve some of these mistakes done by the Interns?

It would be a very good tool to support the translation process.

1. What are the advantages and disadvantages of the creation of a termbank to aid students in the translation process?

I don't see any disadvantage, as long as the term bank is very specific concerning the field and the usage of the words.

Students would have a local source to work on local requirements.

It would be a good source of terminological enrichment for translation practicum.

If it is wiki, it would generate interesting contributions for future generations.
